
In 1889, the 75 drafters of the Washington State Constitution approved the provision making the AMPLE funding of our Public Schools the Paramount Duty of the State. The vote was 73 to 2 in favor.

Washington has the strongest Constitutional Provision For School Funding Of any state in the nation.....

"It is the paramount duty of the STATE to make ample provision for the education of all children residing within its borders."

Article 9, Section 1 Washington State Constitution To protect against the possibility of a corrupt legislature, they also provided for a Supreme Court elected directly by the people...


To insure that our Schools were amply funded, They also added a Provision Prohibiting tax breaks To any person Or corporation.



"The legislature is prohibited from enacting any special laws... for granting corporate privileges. (or) releasing or extinguishing in whole or in part, the liability or other obligation, of any person, or corporation to this state.."

Article 2, Section 28 Washington State Constitution Sadly, for the past 20 years, our state legislature has ignored both their Paramount Duty to fund our schools and the Constitutional prohibition against special tax breaks for the rich.

As a result, during the past 20 years School funding in our State has fallen to near the Lowest in the nation




Half of our schools – more than 1,000 schools – do not meet either the earthquake codes or health codes – resulting in a \$40 billion school construction & repair backlog.

State support for School construction funding Has also fallen to the lowest in the nation - with half of our schools Not even meeting Basic Health Standards!

Meanwhile, the legislature has passed more than 700 (illegal) tax breaks for the rich. They now give away more than \$30 billion per year in tax breaks for the rich.

Where did the money go? It was diverted in to Billions of dollars in Tax Breaks for the Rich!



20 Years of Out of Control Corporate Tax Breaks

It's simple math: We cannot give away Billions of dollars in Tax Breaks for the Rich & still have enough left To fund our schools.



In 2007, a group of school funding advocates called the NEWS Coalition sued the State for failing to meet their Paramount Duty To Amply fund our schools. In 2009, a King County judge agreed. He ordered the State to first determine the actual cost of fully funding schools and then to provide ample funds to cover this cost.

In response, in 2009, The legislature Passed HB 2261 Describing the Average school and promising to Pay for it by 2018.



"Please vote for me One more time... I will find a way To fund public schools Next year... I pinky promise!"

In June 2012, a report was issued calculating that the additional cost to keep the promises made in House Bill 2261 was **\$6.6 billion per year (about \$7 billion today).**



In September 2014, the Washington State Supreme Court Held the legislature in "Contempt of Court" For failing to fully Fund our public schools. They gave the legislature Until the end of the 2015 Legislative session To come up with a Plan to fully fund Public schools.

In 2017, the legislature abandoned House Bill 2261 & broke their \$7 billion per year promise.

Instead, in 2017, the legislature passed The "Levy Swipe" bill That robs local schools Of more than \$1.3 billion per year!

The Levy Swipe Shell Game



The legislature falsely claimed that the Levy Swipe would provide \$8 billion in additional school funding. Instead, after 2018, school funding will drop!

Understanding the Levy Swipe effect on school funding




The State uses "double taxation" in 2018 to increases Property Taxes by \$1.1 billion per year... But then cuts Local School Funding By \$1.3 billion per year in 2020.

The NET LOSS is \$200 million per year And gets even worse over time!

School funding will drop due to Two Poison Pills inserted into the Levy Swipe bill. These poison pills are described in detail in our free report.

School funding will rise in 2018, but then fall every year after:

Problem Solving 101...
